Club, neighborhood groups, exercise or movement groups, Service clubs such as Rotary, bowling, at the hair salon, quilting group, perhaps a retired group from your school building. Anyone who contributed to PSERS when working is a potential PASR member. Spouses/partners who take you to meetings but do not have PSERS retirement can be Associate members but may not hold office.

When chatting with someone, you may find a way to insert a comment about PASR. That's when you can use your "elevator speech".

An elevator speech is a clear, brief message or "commercial" prepared about our organization. It's typically about 30-45 seconds long, the time it takes to ride from the top to ground floor in a building elevator. The idea is to be prepared to share PASR with anyone at anytime, even in an elevator. Gather your ideas and write them down. Cut out the extra details and jargon. Practice to make it natural and get comfortable with what you want to say so you can breeze through it when the time comes.

Absolutely not longer than 45 seconds, approximately 100 words in 12 sentences, it would answer a key question: What is PASR and what does it do? You could note your key points in a note on your smart phone or back of your pocket calendar so it is handy if you want a memory prompt.

#### Here's a simple example:

I belong to the Butler Chapter of PASR, PA Association of School Retirees. It is open to all who retired from PA public schools. Our mission is to serve others in need and to help each other enjoy retirement. We support groups that help our communities. Scholarships are given to students and grants awarded teachers to and paraprofessionals. We meet at noon, four times a year, in March, September and December at Christ Community Methodist Church, and in May in the Masonic Shelter at Alameda Park.
