PASR opposes transition from the current "defined benefit" policy to either a 401k system or a hybrid system that would include both the defined benefit component with a 401k component. According to Mark McKillop, our new PASR Executive Director, the PASR Board of Directors continues to look for pragmatic and logical ways to work toward and support a much needed COLA for our members and all retirees of PSERS.

Every two years, PASR's statewide elected positions - president-elect, vice president, treasurer, and assistant treasurer - come up for election. I commend Veronica for volunteering for this position and wish her the very best of luck.

PASR COMMUNITY SERVICE

Thank you so much for the tremendous amount of items you brought to the March luncheon!

Butler Life Adult Day Center was given two boxes of Bingo prizes for their weekly games and Chris Moyer had Pringle cans to deliver to the Girl Scouts, (We sure do consume a lot of potato chips!) Jim Huemme delivered cut plastic bags for the homeless mats and Mary K Davis delivered many items to the Center Ave. Community School. The Benedictine Sisters of received Pittsburgh vour ink cartridges and will recycle them for gift cards to purchase items they need for their monastery. Sunnyview and Shelbourne Personal Care homes were grateful for the "walker bags", and my garage is full of plastic bottle caps to be delivered to Western Maryland for reimbursement for dialysis treatment for kidney patients who don't have adequate insurance coverage.

Two large post office boxes of coupons were sent to army base commissaries in Grafenwoehr, Germany. Remember, they accept Boxtops for Education, too. (The post master at the Gibsonia,PA site now calls me the "coupon lady"!) That title should go to Mary Angert and the rest of you who, faithfully, contribute those coupons four-five times a year!

Congratulations to Jim and Kay Huemme for being selected 2016 Volunteers of the Year. The award is presented to a member of the state/local PASR. Since both Jim and Kay volunteer for various charities such as the Butler Hospital, Meals on Wheels, their church organizations and other admirable organizations, it seemed fitting to honor this husband and wife team!

When Mary K Davis delivered the school supplies and other items to the Center Ave. Community School, the administration asked for specific items that would be greatly appreciated by

the students. The kids are in need of new or slightly used shoes for boys and girls ages 5-17, socks of various sizes, and toiletries such as toothbrushes, toothpaste, soap, deodorant, shampoo, etc. One other item they mentioned were gift cards from Walmart, Target, etc. If the card is in a large amount, the staff will use purchase smaller them to denominations. I didn't realize how much these students needed. They come from all over the county and are at Center Ave. as an alternative Since their local schools school. determined that they needed extra guidance and support, this is our way to help them.

Continue contributing to our people in need by bringing the above mentioned items to our May meeting. They are greatly appreciated by our Butler county residents and others in need.



Legislative/Political Education Committee It is confusing to understand the terminology that is used with pension reform. The Pennsylvania State ended Legislative session on November 30, 2016 without enacting any pension reform. The proposed bill would have ended defined benefits by changing the new retirees to a 401k like plan. In the long run, new retirees would not have had the same amount of money in their retirement plan as those people who are currently retired. There was no guarantee a new retiree would save the same amount of money as those people on the defined benefits plan. So, where do we go now?

PASR has been working with Dr. Cindy Public/ Private Byerlein on а Partnership. There will be information on this proposal on the PASR website. It has been a two-year process that began with two constraints. First, all retirees must keep their money. There would be no changes in the amount of money deposited for any retiree. Second, there would not be any The issue is the legislature is not keen on the bonds. Our proposal does not need money from the state. We would look to the private sector to get the calculated funds using conduit special revenue bonds. There have been talks with Drexel Heritage (an investment company). They will put insurance around this proposal. They will put 12.1% guarantee each year for 10 Also, vears. they partner with companies in Texas to sell the bonds.

Unfortunately, there is an issue with the legislature. If the retirement

system is behind this plan, then the legislature will not be 100% behind the plan. So, the focus is now on amendments suggested by the late Fred McKillop and Dr. Cindy Beyerlein. They suggest using 25% of the bond issue funds to invest in Pennsylvania infrastructure improvements. Also, 25% of jobs created from these projects remain in Pennsylvania. As this bill continues through the legislative process, other amendments may be added to this PASR Public -Private. Partnership Investment Plan.

<u>Activity #2</u> — Increase Educational Support Grant(s) The Educational Support Committee is encouraging chapters to award one or more Educational Support Grant(s) or to increase the amount of existing grants to active school personnel and/or support personnel in their areas. <u>Activity #3</u> — Increase Social Services Memorial Honor Fund Services The Social Service Memorial Honor Fund Committee is encouraging chapters to increase services to "confined" (hospital, homebound, assisted living and nursing homes) retirees.

<u>Activity #4</u> — Initiate or Expand a Project or Activity Alleviating Hunger The Community Service Committee is encouraging chapters to either initiate or expand a special project or activity, other than just collecting nonperishable food items at meetings, to alleviate hunger in their areas.

<u>Activity #5</u> — Promote Individual Giving to Memorial Honor Fund The Social Service Memorial Honor Fund Committee is encouraging the giving of individual and chapter donations to the Memorial Honor Fund that are given in honor or in memory of individuals.

GOAL 2: Expand/Improve Social Opportunities for Members

<u>Activity #1</u> — Conduct and Publicize Chapter Recreo Events The Recreo Committee is encouraging chapters to conduct and publicize a chapter Recreo event in both the June 2017 PASR Newsletter and December 2017 PASR Newsletter, as well as online on the PASR Recreo calendar.

Pittsburgh Mansions and Flowers Wednesday, October 18, 2017

The Butler County School Retirees, PASR, is sponsoring this trip that will stop in Oakmont, PA at the Kerr Memorial Museum and the famous Oakmont Bakery before having lunch at Hoffstot's Café Monaco. After lunch it will be a stop at the Henry Clay Frick Clayton House, The day will end with a stop at the Phipps Conservatory for the fall flower show.

Kerr Memorial Museum was the gracious residence of Dr. Thomas R. Kerr beginning in 1897. It is a fine example of the late 19th century Queen Anne style home. It was both his residence and medical office. This home gives you a new look at a period in Pittsburgh's history often characterized by the extremes of late 19th century America: fabulous wealth and grinding poverty. This is a part of the middle class that existed and has been often overshadowed. Virginia Kerr, Dr. Kerr's only child, lived in the house until her death in 1994. She never married. She taught English in the Oakmont public schools for 42 year. Upon her death, she bequeathed her beloved 14 room home to the Borough of Oakmont to be used as a museum in memory of her father.

The next stops are at the well-known **Oakmont Bakery** and **Hoffstot's Café Monaco.** These are next door to each other.

The **Bakery** is an experience to savor and enjoy. The showcases are brimming with delicious decisions. You will have a memorable lunch at **Hoffstot's.** Before arriving at the restaurant you have made a choice from a selected menu.

The next stop is the tour of **"Clayton"** the historic home of the Henry Clay Frick family. This tour provides you with opportunities to view fine and decorative arts from the Renaissance to the present, as well as learn how the Frick family lived during the turn of the 20th century. Clayton is an example of both the home of a wealthy Pittsburgh family and of late Victorian architecture and interior design, Also learn local history and Victorian social customs in the family's home. Ninety percent of the furniture and artifacts on display are original. You may also visit the Automobile Museum, Art Display, Greenhouse and Museum Book Shop.

The last stop will be at the **Phipps Conservatory and Botanical Gardens**. This is one of the nation's oldest and largest Victorian greenhouses. This trip is scheduled at the time when fall flowers are featured exhibits. You will have time to explore on-your-own throughout the gardens.

This trip will have much walking and limited restroom facilities until the afternoon. The Butler PASR sponsors trips to benefit numerous activities that support Butler county schools, students and teachers.
