Two months ago my blood test showed that I am allergic to wheat, egg whites, cow's milk, peanuts, shrimp,

and sesame seeds. The asthma office nurse read me the list on the phone but could not explain anything. The printout sent by the office via US Mail gave test results but not how to deal with it. Now mix that with a PCP diet previously prescribed to lower cholesterol. Aside from plain fruits, vegetables and some grilled chicken, my meals are now a rather drab affair. Anything with dairy and wheat is out. Yes, there are lots of gluten-free products. But check the box directions for mixing: add eggs and milk. Yes, there are substitutes for eggs. I've tried ground flax seed (diluted as per instructions) as well as applesauce. Just threw out the results from this morning's baking, once again. Yes, I have found special items at Aldi's, Foods, Giant Eagle, Whole Sorgels. But other than raw foods, I have yet to find frozen or boxed food that is gluten-free, dairy-free, egg free, and peanut-free - all at the same time! It's all cooking from scratch.

I was told that the hospital dietician could help; two month wait for the appointment!!! Met her this week. She had never dealt with my particular problem and had never previously seen an allergy report of any kind. She listened and did give me some internet print-outs that she searched during my appointment but it is up to me to wade through it all and figure it out. It feels like a mountain to be climbed.

But my point here is *not about me*. **More importantly**, *it's about all of us*. This is just my particular flavor-of-the-month problem used for illustration; we **all** have challenges.

It is far more tiresome to advocate for ourselves as these new problems emerge with age. Seems far easier to just go back to the old ways – even if they make us sick. Seems far easier to just ignore it all – after all, "I don't want to be a problem; I'll manage." Seems far easier to just pretend it isn't there – maybe it will go away, but it doesn't.

No matter what personal challenges you are now facing, join with me in promising to be an advocate for yourself. Work to understand your new situation and find ways to cope. Incorporate new ideas, new foods, new treatments, and whatever it takes to best move forward! That's how we'll all see 2022, 2023, 2024, and beyond!

Things are still not back to normal, but we're getting there! At our September luncheon, I asked everyone to write down the volunteer activities our members were still able to do during the pandemic. Many of you were able to continue doing your "Meals on Wheels" distributions to our neighbors in need. Because this "needed" service is so necessary to those who can't get out or don't have anyone to shop or cook for them, "Meals on Wheels" was never cancelled! Other volunteer services included: sewing face masks for those in need, cutting plastic bags homeless for the mats, knitting/crocheting Linus and other types of blankets, making guilts and

The Director is responsible for attending four Board of Directors' meetings and the committee meetings for the committees to which you are assigned. That is usually two committees. ZOOM is an option for attendance at these meetings. Please give heartfelt consideration to filling the Director position for Region 8.

I have greatly enjoyed being your director for the past several years. Your support and cooperation has given me the confidence to move on to a state officer position. Thank you for everything that you do for Region 8.

### **House of Delegates Summary**

House of Delegates (HOD) change in bv-laws-the nominating committee may put up to 3 names on the ballot. Also, nominations from the floor will be accepted. The proposal to eliminate the positions of treasurer and assistant treasurer died for lack of interest. A leadership training session will be held November 9-10 via ZOOM. Services/Memorial Honor Fund has a cap of \$800 per chapter beginning 2022. Discounts for BJ's, which is opening in South Fayette and possibly Ross are available. State RECREO trips include the Virginia International Tattoo and the Taste of Scotland and Ireland. Propane and heating oil discounts are available through Tank Farm and Heat USA. PSERS is being investigated by the FBI and SEC is now involved. Pensions are not in danger. The investigation is into questionable trips and the actions of the investment advisors.

Pennsylvania has one of the highest senior populations in the country and our seniors are more active than ever. The Office of Attorney General is here to help protect and educate seniors on what to watch out for when they are out socially, traveling or simply enjoying their home life.

- If you don't know the number, DO NOT ANSWER- Let your machine pick up.
- Examine your mail. If the postmark is from outside the US it is most likely mail fraud.
- Beware of anyone demanding payments in gift cards or prepaid credit cards.

#### **BE ALERT**

- Talk with family members and friends about your travel plans and daily activities.
- Be aware of your surroundings, walk in groups of two or more.
- Never post your travel plans on social media sites.
- When driving, never pull off or park in a secluded area. Drive to a well-lit public place.

#### **BE SECURE**

- Close and lock windows when you leave the house. Keep your doors locked at all times, even while you are at home.
- Don't let strangers into your home. Ask all delivery people and utility workers for ID.
- Never deal with a contractor who shows up unsolicited or with "left over materials." Always use a contractor that is registered with the Pennsylvania Office of Attorney General. To check if a contractor is registered, visit www.attorneygeneral.gov.
- When you are gone for more than a day, make sure your home appears occupied —use automatic timers to turn on lights and a radio or television.
- Always place a hold request on mail and newspapers while away. If possible, park a second vehicle in the driveway.
- Do not hide your keys under the mat or in other conspicuous places.

### **BE SMART**

- Banks, credit card companies and government offices never call you to verify your personal or account information.
- Never give your personal information to anyone who contacts you and asks

for it; only when you initiate the contact.

- Don't carry unneeded credit cards or your social security number with you.
- Law enforcement agencies will not contact you and demand that you make a payment of fines over the phone or internet.
- No one can win a lottery from a country they've never visited or a sweepstakes they didn't enter. "You have to play to win."
- No offer to share millions of dollars, recover wealth, or provide large sums of money for you to distribute to charity, will require you to provide "front money."
- Beware of health care scams. Never release information to any health service provider that you did not contact directly.
- Only use ATMs that are inside of a bank or business and shield your PIN from view of others. If the device appears to be altered, report it right away.
