She will use the grant money to continue assessing resources (i.e. lesson downloads, assessments, and videos) to implement THE CAFE SYSTEM herself. PISI News**

On December 8, 2017 - Professional Insurance Services Inc. (PISI) - (our Third Party Administrator or "TPA") merged with a company located in Austin, Texas named AMBA (Associate Member Benefits Advisors). A Third Party Administrator simply acts as the entity that does the marketing, collects the premiums and is the record keeper regarding members who sign up and cancel benefits. The exact nature or legal description of the "partnership" between PISI and AMBA is currently not known by us. It is important to note that on May 18, 2015, PISI and PASR signed a five year contract for PISI to continue as the PASR Third Party Administrator. However, due to the merger and the terms of the original (2015) contract, PASR currently does not officially have a Third Party Administrator. We were asked by PISI to sign an

additional document that would formalize the partnership. It is very important to note that the PASR insurance contracts (Davis Vision and United Concordia in particular) are signed directly by the Executive Director with each provider. Every insurance contract remains in force for each of our members. This merger between AMBA and PISI does not alter these contracts in any way. Again, to be clear, our insurance contracts are directly with the provider and not with PISI. PASR members can continue to sign up for dental and/or vision insurance coverage through PISI (Dental – United Concordia; Vision – Davis Vision). New and current subscribers are to make payments to PISI until further notice. Partly as a result of being informed “after the fact” of this merger and not before or during, on January 23, 2018, the PASR Board of Directors made the decision to explore all options regarding the best way to provide insurance coverage for our members. The Board passed a motion instructing the Executive Director to: 1) Notify PISI that PISI is not allowed to contact any chapters or regions within PASR while PASR explores all insurance options. This includes PISI representatives speaking at PASR events at the state and local level. This step is necessary so that PASR can have a period of time to explore all options available. Also, the Board requests that anyone within PASR report any contact with PISI representatives to Headquarters. 2) Advise the Chapters of this decision and the reasons behind this decision. Since early last year, PASR has instituted many changes to the

operation of the Association. We have been instructed by the Board of Directors, to attempt to improve PASR in any pragmatic and practical way. To that end, the Board may decide as one of its options to conclude that the PISI-AMBA merger would provide the best service for our membership. It is the job of the office staff to research every aspect and to give the Board of Directors (on behalf of the Association) every possible option and the supporting documentation for their review, evaluation and ultimate decision.

From Our Region 8 Director

The new calendar year has started, and with the turning of the calendar there are some changes that have occurred at the state level of our organization. The new officers were sworn in at the state convention in October and they took office on January 1, 2018. They are Gary Parker – President, Judith Schaffer – President Elect, William Neugebauer – Vice President, Barbara Mitcho – Treasurer, and Stephen Vak – Assistant Treasurer.

Veronica Rozic has been appointed as chair of the state membership committee. As such, she can no longer act as our chapter or region membership chair. Please give consideration to serving as our region membership chair. If you are interested, please contact me. (Editor’s Note: Sharon Kline has stepped up.)

Please read carefully the letter from our Executive Director concerning PISI. As of now continue paying your insurance premiums as you have

always done. Your contract is with the insurance companies. PISI is a Third Party Provider. If you have any questions, I will be glad to talk to you about this. Be assured that the State Board of Directors and the staff are working to provide you with the best benefits possible. You will be notified if there is any change concerning PISI as the Third Party Provider for our benefits. Our lobbyist and executive director are continuing to make contact with

legislators concerning a COLA. I will let you know if there is any information forthcoming on this front.

I am honored to represent you as Region 8 Director. Please let me know if there is anything that I can do for you.
