#### **COMMUNITY SERVICE**

I hope you are enjoying this time of year! I know many of you are using these autumn days helping others. So I wanted to remind you of the various projects our Butler Chapter of PASR continues to help.

Since we have "adopted" Slippery Rock Elementary School (K-5) for the 2015-2016 school year, we are in need of winter items such as gloves, mittens, scarves, hats, socks, ear muffs, toys, puzzles, and things children would like to receive for Christmas. As usual, we are still collecting pop can tabs, ink cartridges, plastic lids, Pringle cans, Butler Life Bingo prizes, plastic bags for making "mats for the homeless", and manufacturers' coupons and Box Tops for Education.

We were able to send 3 medium size USPO boxes filled with coupons to military commissaries in Europe. Two boxes were sent to Army commissaries in Illesheim and Wiesbaden, Germany and the third box went to an Air Force commissary in Lakenheath, England. Remember to separate the coupons into FOOD and NON FOOD categories and place them in separate baggies or envelopes. The expiration date requirement should not go back more than two months. (Oct. 2015).

#### **Convention Notes - Mary K. Davis**

I was privileged to help present the Membership workshop at the state convention in Pittsburgh on October 6, 2015. The state membership committee decided to talk about what membership can provide. We based our presentation on Travel, Economics, Altruism, and Making and keeping friends.

The room was set up for a Round Robin presentation. Each presenter moved from group to group talking about their part of **TEAM.** We talked to each of the four groups for approximately 10 minutes and then moved to the next group. The attendees seemed to really enjoy this approach. It gave them time to ask questions and make comments. As a presenter, I found it more enjoyable because I had more direct contact with the attendees. I was also able to attend the Enrichment Workshop, Behind the Scenes of Entertainment. The presenter had worked for DeCaesar/Engler concert promoters for many years. He talked about his experiences with the many groups that he had the opportunity to work with during his time as a concert organizer. He would meet the entertainers at the airport and transport to any place they needed to be during their time in Pittsburgh. He is now teaching a course at Point Park to teach the next generation what he had to learn on the job. It amazed me what all goes on behind the scenes so that the audience can have a wonderful experience when attending a concert.

On Monday afternoon I went on a tour of the Warhol Museum, PNC Park, and Heinz Field. All three venues were very interesting. I wish we had had more time at each stop. We had the opportunity to meet Andy Warhol's nephew while we were at the museum. We were at PNC Park the day before the Wild Card game. The grounds crew was busy preparing the field for the next day. Our guide told us that the dirt on the mound is a special blend that comes from Slippery Rock. At Heinz Field we were able to enter the locker room. The Steeler emblem is in the

carpeting and no one steps on it. The guide said that the team kneels around the emblem before going on the field. If you ever have the opportunity to tour any of these facilities, I think you will be fascinated by what you see.

**PASR Convention 2015 - Reflections Peg Harding - Butler Chapter Delegate**Even though I attended the 2015 PASR
Convention held on October 4-7, 2015 with
my left hand wrapped in a soft cast because
of a wrist procedure the week before, I
learned many things about our
organization, our city, and my ability to get
around with the help of fellow PASR friends.

One of the personal enrichment seminars I attended was entitled "Stay Sharp! Activities to Keep Mentally Fit". We were told that doing activities such as Sudoku, KenKen, Hashi, and Shape Equations puzzles keeps our mind alert. I wasn't surprised when they said Word Search really didn't do much for our mental skills. They taught us how to "work" some of those puzzles and directed us to websites to learn more about the games.

I also attended two "Recurring State Committee Seminars". Both of these were held on Tuesday afternoon. The first dealt with L/PEC and Legislative information. The presenters encouraged **PASR** write members to or e-mail their regarding legislators positions and initiatives affecting pensions. We need to let our state representatives and state senators know that as retired school employees, we think that moving to a 401K type of pension plan will 1.) starve the current defined benefit plan, and threaten our pension, 2.) threaten health care assistance for future retirees, and 3.)

force PSERS to reduce coverage, or increase premiums down the road. The presenters, also, told the audience that less than 14 out of every 100 retirees receiving retirement benefits from PSERS are state members of PASR. How sad!

The second seminar was presented by the Community Service Committee. We have PASR members volunteering on a "Youth Accountability Program" set up in various counties across the state of Pennsylvania. The purpose of such a program is to respond to the needs of youth and their families in such a manner as to avoid further involvement in the Juvenile Justice System. The program offers an alternative way of handling juvenile first time summary, misdemeanor, and non-violent Felony offenders. Adult volunteers serve on panels along with professionals and law enforcement officers to help the juvenile and his/her parents devise a contract for a certain period of time that will enable the juvenile to become a positive member of the community. If the contract is completed, the juvenile will not have anything put on his record concerning the offense. Butler County, currently, does not have a program like this for juveniles, but some of you may want to find out more about how other PA counties and PASR volunteers went about setting up this alternative to help their juveniles.

Lastly, I went on a tour of the Andy Warhol Museum, PNC Park, and Heinz Field one afternoon. I thoroughly enjoyed seeing some artwork by one of our "native sons", Andy Warhol. But going inside the lockers rooms, the private boxes and press rooms, the dugout, and standing on the sidelines of the home of our Pirates and

Steelers was amazing! The tour guides were very helpful in answering our questions and showing us where Pirate and Steeler greats have their "cubbies" (I learned that word from some elementary teachers - it refers to their "lockers"!) Hopefully, we will schedule a tour of those facilities as a RECREO trip, sometime.

The 2017 PASR Convention will be held in Lancaster, PA. To become a delegate, you must be a state member of PASR, so make sure to pay your state dues and get ready to see some Amish buggies and great areas east of us.

#### "Never Scrub Another Toilet"

A Personal Enrichment Seminar Veronica Rozic

The title of this seminar caught my eye. HRM Pat Condelli, "The Cookie Queen" presented this session, based on her third book. She worked for the Valley News

Dispatch as a reporter, editor and special features writer. After leaving that job of 30 yrs., she has operated her home based business, "Cookie Queen Cookies, Cookbooks, & Entertainment", beginning in 1992. Subscribe to her weekly newsletter by writing "subscribe" in the subject line of an email to tocookiequ@verizon.net.

She spoke about several tried and true shortcuts in and around the house. Unlike other shortcuts published, the author has perfected those listed in the book <u>Never Scrub Another Toilet</u>. 2nd edition. Some of the shortcuts include:

- 1. **Keeping Pizza Hot** After buying a pizza, you want it to remain warm until you get home. Turn on the front passenger seat warmer and place the pizza box on the front seat.
- 2. **Oven Racks that Stick** There are times that the rack in the oven will not slide in/ out. Dampen a paper towel with some vegetable oil. Rub it on both the rack and supports inside the oven.
- 3. **Keeping Kisses in the Cookie** As the holidays approach, many people bake the Peanut butter/ Hershey Kisses cookie. The Hershey Kiss easily falls off of the peanut butter cookie. When it comes time to put the kiss on the candy, put it on with the point facing down. Put the cookies back into the oven for one more minute. The kiss will adhere to the cookie better.
- 4. **Chopping Onions** There are many suggestions on how to clean onions without eyes watering. Running water, chewing bread, etc. does not work. Instead, burn a small votive candle.
- 5. **Reheating leftovers** Try reheating left overs using a microwave steamer for two minutes, not any longer so that

- everything tastes as good as when it was made. Microwave Steamers are available at Bed, Bath, and Beyond.
- 6. **Never Scrub Another Toilet** Spray the bowl with Clorox Clean-up, close the lid, and walk away for at least an hour. (It is better to do this at bedtime, but not absolutely necessary.) Do not do anything else to the bowl except spray it
- 7. **Unsealing an envelope** Everyone has paid a bill, but forgot to put the check into the envelope. Place the sealed envelope into the freezer for 1-2 hours. Tape may be needed to reseal.
- 8. **Removing Splinters** Put a drop of Elmer's Glue where the splinter is. When dry, peel the dried glue off the skin. Most of the time, the splinter sticks to the dried glue.
