President's Message




During my teaching years, I learned while working with certain administrators, that it was most effective with any kind of complaint to go in at the same time with a well thought-out remedy. That strategy often helped to bring about a favorable change.

When PASR Butler Chapter started to venture out with Zoom last spring, we were feeling our way. I did a LOT of "independent study" and got somewhat comfortable. In late summer I started to ask PASR to see what other chapters were doing. That led to some emails and a suggestion that PASR needed to offer some

sort of training. I did this, knowing that I would be willing to help, if asked.

I am not on a state committee but was pleased to be asked to help to create a Zoom training about using Zoom which was offered on February 23 to chapters across the state. My part of the program was on making accommodations and the mechanics of holding a meeting via Zoom. The whole program was recorded and you can view it.



There are some great resources there for you. Go to <u>www.pasr.org</u>. Login as a member. On the members only page, under General Resources, click on Zoom Information. Click on any blue link for a document. Click on the video to open the training program, "Groomin' for Zoomin".

On March 6, I was finally able to give up my "second job." Well, it felt like a second job. Since the day my husband and I became eligible for the covid-19 vaccine, I started to make the rounds on the internet to get an appointment. First, once a day; then twice a day with assorted sites; then as I saw Facebook postings that my friends were getting their first and even second shots, I upped it to three times daily regularly checking websites of two hospitals, three pharmacy sites (and all branches), and two search sites. Finally on March 6, I booked appointments in Clarion for March 8, so I could stop combing the internet. Being a Clarion State graduate, we did enjoy a drive through the campus after the shot. As of this writing, Butler now has lots of openings. Hope you are successful!

Clarion Hospital had a well organized location. They were using an empty Kohl's store, so there was lots of room inside and lots of parking outside. However, the whole process of getting the appointment was WAY too difficult.

From a Facebook posting by a friend of mine: "This scheduling is a huge mess. If the people in charge had just gotten about 5-6 teachers in a room with unlimited coffee and tea, a plan would have been put in place. The plan would have been color coded, alphabetized and laminated!!" Well said, Becky Sheavly Thomas!



Yes, I registered on the Do Not Call List. Yes, I have an app that catches scam calls on my cell phone. Nevertheless, my husband and I continue to get scam calls on our cells and the landline. I've learned some more about these kinds of calls.

There are just a few call generation centers located around the world. They maintain the phone number databases, make the recorded robo calls with spoofed called ID information, and then route the call to a subscribing call center if someone answers. That's why there is usually a delay before a voice is heard. One call center in Kolkata, India simultaneously runs at east three separate scams. There are similar operations in Mumbai, India and Mexico City, Mexico.

REMEMBER:

- 1. Your Social Security number will NEVER be suspended.
- 2. The IRS contacts you by mail, not by these kinds of calls. IRS threat calls are fake.
- 3. If you didNOT enter a contest, you didn't win! If you are told by a caller that you won a prize, say from Marriott or Royal Caribbean, it is illegal that you must pay shipping or taxes or anything else to get the prize. Never send money or gift cards. Don't give your credit card info. It's a scam.

- 4. It can be hard to dismiss their scripted comments that allege to be from Microsoft or Windows or even the IRS. Their message can be scary by threatening arrest or a huge charge on your account. No, Microsoft has NOT detected any problem with your computer. Hang up. Hang up. Hang up and don't think twice about it.
- 5. Understand that you can't reason with them or persuade them. The caller has a script that they must follow. They can't engage in conversation that you want to lead. Hang up. Hang up. Hang up.

If you are concerned that some problem could be legitimate, then YOU follow-up with a call to your bank or the gas company or whatever group you think has called you with something suspect. If you make the call to a known number, you will be talking to a legitimate agent and can verify if there really is a problem.

Biography of Meghan Speer Our March Program Speaker




I've gone by a lot of titles over the years: daughter, sister, friend, student, cashier, coordinator, director, Vice President, CEO, Vice President again. We live in world that а

defines us by these labels and one that looks at us in confusion when we manage to reach a top-level one only to step away from it. That's exactly where my story began.

My journey to adding "author" to my list of titles started in July of 2020, on a walk with a dear friend, she proposed that I start to journal the roller-coaster of experiences I had been on for the prior twelve months to that. Professionally, I was in the midst of a transition and there was certainly plenty to process! What started as a journal evolved over the next few months was "Letting Go of Should", a memoir of my leadership, career, and life adventures which launched in January of 2021.

"Letting Go of Should" looks at the lessons I have learned over the years about embracing who I am meant to be and leaving behind the expectations that come from trying to please everyone else. This is a huge struggle for so many people and it's one that started early in life for me. One of my earliest memories is taking my dad to Open House Night when I was in Kindergarten. I was so excited to show

him my school and my classroom and have him meet my teacher. When we aot to the school we parked near а different door than I was used to entering and my five-year-old brain confused. aot Ι didn't know how to get to my classroom



from where we were and we kept walking in because even at that young age I couldn't stand the thought that I was messing up our big night out together just the two of us by admitting that I didn't know where I was going.

Through the years, I found that the times I was happiest, the times that I experienced the most growth and flourishing, were the times that I was learning, growing, and leading from my gifts and talents. The seasons where I was most frustrated, depressed, and unsuccessful were the times where I was too focused on what someone else thought I should do or should be. I wish that I could say that I learned the lesson once and was done, but it has taken me a few long cycles to get to appoint where I am committed to not going backwards; to stay living into who I am created to be and being true to that.

I read a quote once that said "Be the adult to someone else that you needed when you were their age". While I was writing "Letting Go of Should" I had that quote on an index card by my computer because I wanted the constant reminder to speak honestly about my struggles and journey through my 20s and 30s because I wish that someone had been that honest with me. My goal in the book is that someone else who

struggles in the same way might find some encouragement in the fact that they are not alone and that they are enough just as they are.
