President's Message



We are starting to have some nice weather but I have an indoor job for myself – and for you, too.

This involves writing an actual letter that you

compose yourself, not just copy a form letter. Our lobbyists tell us that Senators and Representatives put greater weight on individual letters from their actual constituents. Phone calls are not as effective. This is not a time to email.

First, you need the addresses for PA, (not Federal) reps. Here's one way:

On your computer, search **PA Find Your Legislator** to locate the dedicated website. Type in your home street address. It will then display your state senator and state legislator, as well as US House and US Senators. Click on the blue, underlined name. That takes you to their page with their personal information, including office address. Remember that there was some redistricting.

Now, to the body of your letter. PASR is asking members to contact their legislators to show support to pass a **COLA, Cost of Living Adjustment**. You don't need to write all of these, but consider ideas you could include.

- 1. It has been far too long since the last COLA.
- 2. Since the passage of Act 9 of 2001, PSERS retirees have lost at least 1/3 of the value of the pensions due to inflation, (Cost of Living).
- 3. About one-third of all PSERS annuitants have a pension of under \$10,000 per year.
- 4. Almost one-half of all PSERS annuitants have a pension of under \$20,000 per year.
- 5. All annuitants who retired prior to 1986 have a yearly pension below \$7,623.

Butler County Chapter has chosen the Knoch School District to receive this award and two \$100.00 Education Support Grants.

The purpose of the Lauretta Woodson Award is to recognize an educator and support professional who have exhibited creativity, initiative, productivity relevant to the learning process and growth of children. Lauretta Woodson, a retired assistant professor at Temple University joined PASR in 1988. Upon her passing, she begueathed a sum of money to PASR to be used for the support of public purpose education. Butler County PASR Ohio Amish Country Tour

A trip is planned for June to the largest Amish/Mennonite settlement in the United States. Join PASR Butler for an overnight trip to Holmes County, Ohio.

TUESDAY, the trip begins with a stop at BEHALT Cyclorama, the Amish and Mennonite Heritage Center, that includes a pioneer barn and 1850's one room schoolhouse. The next stop will be at the Troyer Country Market where you can sample and purchase many food items including baked goods and canned Amish Wedding Foods.

You will have lunch on-your-own at the Cafe in the Market. After lunch, we will have a two to three hour step-on guided tour of the Backroads and Byways. The tour will include seeing how the Amish work, farm, raise animals, make money, and do things without the modern conveniences most of us know. There may be time for short visits to family-owned shops. A highlight of the trip will be bountiful dinner this evening at the home of Anna Erb. Then, it will be time to check in at the **Carlisle Inn, Sugarcreek,** for a good rest getting ready for another busy day.

WEDNESDAY will begin with breakfast at the Inn. The morning may be spent getting acquainted with the Village of Sugarcreek, the World's Largest Cuckoo Clock and the painted Swiss murals on many buildings. Some of the shops are Fabrics and Quilts,

The Gospel Shop, Collectors Decanters & Steins, Harvest Thrift Shop, Dutch Valley shops and others.

After a light lunch at the Dutch Valley Restaurant and Bakery go to the the Ohio Star Theater for the show "Dear Soldier Boy". This is a new Blue Gate Musical that takes place in 1990 after Iraq invades Kuwait and when two Amish girls decide that they want to do something to help the American troops. You must see the show to see the drama unfold.

After the show, there will be a stop at a winery and cheese house before starting for home. The last stop in the Amish area is dinner at the Amish Door Restaurant and Bakery in the village of Wilmot, OH. There is so much to be seen and experienced, it is impossible to do it in two days; you will want to go back another time.
