Every year a school district in Butler County is able to choose a professional and support staff member to receive a PASR education grant for projects within the school district. Alphabetically, Mars Area was the next on the list for the awards. Last school year 2015-2016, Karns City received the awards. We are happy to announce the BC3 \$500 PASR Butler County Scholarship award winner is Sara Scarpino from Evans City. Sara is studying Early Childhood Education at BC3 and has been invited to our December luncheon. Please be there to congratulate her. She has a wonderful story to tell about her reason for choosing education as her major and what she has been doing since high school. The John Dillon Award will be presented at the December luncheon. The certificate was delivered to me at the PASR Leadership Conference in October. The John J. Dillon PASR Service Award, which began in 2004, provides the opportunity for chapters to recognize individuals that have given service to the Association. Dr. John J. Dillon was a past president of the Association who was a consummate PASR volunteer. He held a record thirty-eight positions in PASR, ranging from the local to the state level.

Dr. Dillon retired from the Superintendent's position in the Brentwood Area School District in 1986. Continuing his concern for education and his peers, he immediately became a member of PASR. During his twenty-one years as a member he provided tremendous service to the organization. He was greatly involved at the chapter and region level, but most especially at the state level where he was an instrumental figure in helping PASR to become what it is today. He served as president of PASR in 1994 and 1995.

PASR wanted to develop a way to recognize the outstanding service provided to the Association by individual volunteers at the local, region, and/or state level. Since Dr. Dillon was an ideal member, the PASR Board of Directors decided to name this recognition award in his honor.

Each chapter may grant the John J. Dillon PASR Service Award annually to the member of its choice. The Executive Committee for each chapter may nominate one person to receive this recognition. Eligible candidates include any volunteer serving PASR at the local, region, or state level except a current chapter president, region director, region representative, or statewide officer. An annual listing of the John J. Dillon PASR Service Award recipients is produced, framed, and hung on display at PASR Headquarters in the John J. Dillon Hall of Fame. Additionally, a certificate is provided the chapter president for to presentation by the chapter to its honoree. Last year, the John Dillon Award was presented to Joanne Nolsheim. At the PASR Leadership Conference held in Hershey, PA on 17-18, Mary Κ October Davis, Veronica Rozic, and myself attended a talk by Pedro Rivera, the head of the PA Department of Education. Mr. Riviera has been in office since 2015 and has been instrumental in setting up a School Performance Profile, Education Funding Formula and graduation requirements which can be viewed on line through the PA Department of Education. He believes that a holistic approach is needed for graduation and not just standardized testing results. We also heard from Tom Malefic, the founder, president, and CEO of EZSolution. This company has been hired to set up and run the PASR state website. The new version of the website started on October 31, 2016. Our local Butler County website is linked to the state site. Thanks to Polly Shaw for being our "non paid" founder, president, and CEO of our PASR Butler County Chapter website and our newsletter editor-in-chief! We calling our newsletter, are now JOURNEY, because we are all on a journey through retirement!

The tally sheets are very important because they help in determining how many volunteers hours our members contribute to the local community and they help in choosina Community Service а Volunteer honoree for 2016. We sent a large bag of needed items to the Center Ave. School in Butler, PA to help the students from across Butler County. Those students have a variety of academic and emotional problems, so getting something for being a good student is very rewarding to them. We will need more items this time, too. Manufacturers' coupons and "Box Tops for Education" tags were sent to the Navy and Marine bases in Guam and Yokosuka, Japan after the September luncheon. Thanks so much for cutting and placing them in FOOD and NON FOOD bags! Eight

baby dolls and baby blankets were delivered to St. Barnabas skilled care facility in Gibsonia, PA. The activities director was going to use them for therapy sessions with the dementia patients. Chris Moyer was given large garbage bags of Pringle cans for the Girl Scout cookie drive. The homemade cookies will be placed in the Pringle cans and then shipped to military personnel overseas for the holiday season. Thanks Chris, for giving us a great opportunity to help the Girl Scouts and the military! As usual, continue to bring pop can tabs, plastic bottle caps, ink cartridges, cut strips from plastic bags for the homeless project, Bingo prizes for the Butler Life senior day care center, non-perishable food and paper products for the local food bank, and other items to be mentioned throughout this newsletter. Women's shelters and the homeless need a variety of hygiene items, so we are asking that when you go and stay at a hotel, motel, or other places that give free shampoo, hair conditioner, hand lotion, or soap to bring them to the luncheon, also. Their population is both boys and girls ages 8 – 18, with most of them students in 7th – 12th grades who are dealing with behavioral and emotional issues. Many come to school without breakfast. Some have not had the opportunity to bath. Clothing and personal hygiene items would be given to the school nurse to distribute as she sees a need. The Tornado 200 is an incentive program where all students can earn good behavior points to cash in for rewards. Here are some suggested items:

- Shoes
- General clothing: shirts, pants, sweatshirts, etc.
- Underwear and socks mostly for male students: maybe kids size 6-adult XL
- Deodorant
- Hair combs/brushes
- Toothpaste, toothbrushes, dental floss, mouthwash
- Snacks for Tornado 200 (i.e. individual bags of chips, cans of pop/juice boxes, etc.)
- \$5-\$10 gift cards for Tornado 200 incentives (Dunkin Donuts, Walmart, iTunes, McDonald's, Burger King)
- Grand Prizes for Tornado 200 (midyear and end of year for Alt. Ed. and ES)-last year the school gave away an iPad and Xbox
- Classroom incentives (candy, gum, mints, snacks)
- Age and content appropriate DVDs for in-classroom use
- Gift cards to local retailers to purchase shoes/clothes/etc. for students

Dear PASR Butler,

Thank you for providing three gift cards for the flood victims on September 30, 2016 to help with the flood recovery in the Connellsville area. The damage caused by the flood on August 28, 2016 was terrible; however, the response by the community and friends of the community has been inspiring. Thank you for being part of this amazing effort to help our neighbors recover from this difficult situation.

As a result of this flood, 255 homes were damaged, 60 homes received major damage and 31 homes are considered to be destroyed. The estimated total loss is \$7.7 million (homes, buildings and personal property). Fortunately, there was no loss of life or serious injury.


