## Ten Helpful Hints

## PASR Butler Chapter 2023-2024 <br> Lauretta Woodson Awards and

 Education Support GrantsThe Pennsylvania Association of School Retirees (PASR) is an organization comprised of members who are all retired Pennsylvania public education employees. Our members have dedicated themselves to fostering education in the public schools and volunteering their services in communities where they live. We are former teachers, administrators, counselors, nurses, secretaries, aides, bus drivers cafeteria workers, maintenance staff- in short, anyone who is now receiving a pension from the Pennsylvania School Employees Retirement System (PSERS). PASR's mission is "To serve others in need and
help one another enjoy retirement." The Butler County Chapter of PASR awards two employees every year who are employed by one of the nine Butler County School Districts and BC3. For this school year, 2023-2024, our Butler County Chapter has chosen the Butler Area School District to receive this award and two \$100.00 Education Support Grants. The purpose of the Lauretta Woodson Award is to recognize an educator and a support professional who have exhibited creativity, initiative, or productivity relevant to the learning process and growth of children. Lauretta Woodson, a retired assistant professor at Temple University joined PASR in 1988. Upon her passing, she bequeathed a sum of money to PASR to be used for the support of public education. The purpose of the "education support grants" are to encourage innovative classroom ideas and professional development. Page 1 Ed. Support Grant and Loretta Woodson Award These grants consist of monetary awards. The funds are to be used to help finance special programs, activities, or supplies benefitting public school children. Butler Area Superintendent, Brian White, requested the building principals to submit an educator and support professional to receive these awards. The Butler Area Human Resource person, Kristen Clouse, submitted both an educator and support professional from Emily Brittain Elementary School to be considered for these awards. Katie Kosick, an Autistic Support teacher, was chosen for the following reasons according to Ms. Clouse. " Katie's autistic classroom is one of the first in the district to apply the Applied Behavior Analysis (ABA) model in her classroom. She, recently,
presented at the National Autism Conference where she spoke about the importance of teaching all students the essential skills that enable them to selfadvocate." Kathryn Yeamans, an Autistic Support Paraprofessional, was chosen for the following reasons according to Ms. Clouse. "Kathryn is dedicated and passionate about serving students. She recently became the first paraprofessional in our district to become a Registered Behavior Technician (RBT). Her skillset as a Registered Behavior Technician will help her to support students in our autistic support classrooms." Both awardees will receive $\$ 100.00$ from the Butler Chapter of PASR for use in their classroom endeavors with their students, a plaque, and a PASR pin. The 2023 Lauretta Woodson Award states, " In Recognition of Unselfish Dedication and Exemplary Service to the Emily Brittain Elementary School and the Butler Area School District in the Commonwealth of Pennsylvania. We thank you on behalf of the Youth of Today and the Future of Tomorrow."

The center will offer services spanning from employment and housing assistance, financial counseling, education, health care advocacy, referrals to programs that support homeless or at-risk veterans, and opportunities for community outreach.

## MARCH PROGRAM



Lawrence County, PA was created April 5, 1849 with New Castle as the county seat. President Zachary Taylor arrived via the Beaver-Erie Canal extension during his summer 1849 visit to New Castle and the northeast states. In 1893, Antonio Zambelli took a leadership role in the business that led to New Castle being recognized as America's Fireworks Capital. In 1907 the Warner Brothers opened their first movie theater. The Interurban Railway (The Harmony Route) provided easy access to Butler and Pittsburgh between 1908-1931. Bob Hope, Perry Como, and Evangelist Billy Sunday all made appearances in New Castle. As a bonus, we'll take a look at the mansions in today's North Hill Historic District, along with the Hoyt Institute and the Scottish Rite Cathedral. Enjoy a picture survey of our neighbor to the west, as presented by local author Polly Shaw.
