Zoom Teleconference Attendance: Polly Shaw, Jim Huemme, Mary K Davis, Ruth Scott, Peg Harding, Sharon Kline, Joanne Meredith, Donna Vogel, Patricia Hauman. President Polly Shaw called the meeting to order at 11:04 AM. Minutes for February 6, 2020: Approved after some spelling corrections.

President (Polly Shaw) report: Due to a strong direction of State PASR - the general membership meetings for March 2020 and May 2020 have been canceled. PASR State President, Judy Schaffer, and Executive Director, Mark McKillop, sent emails concerning PASR's statement in response to the Coronavirus situation. The statements

We are hoping our members will not lose interest in PASR because of the canceled general membership meetings and continue to pay their dues to the organization. There is a change in general membership luncheon host schools Moniteau will host the September meeting and Seneca Valley will host the December meeting.

Region VIII Director (Mary K Davis) Report: PASR state office is working on a skeleton crew with one person in the office at a time, and they are running on a 12-hour delay in responding to inquiries. On April 22, 2020, there will be a teleconference with the Board of Directors to approve the upcoming budget since this is a non-delegate conference year. SSMHF is hurting financially and they are looking for ways to help this committee. Each chapter is asked to donate \$50.00 to assist our members. (Our executive council moved (Mary K Davis) and seconded (Ruth Scott) to send \$50.00 to SSMHF from

the Butler County Chapter. Motion passed. There has been a gain in state membership because of letters sent to 2016-2017-2018 retirees. Ruth Scott suggested that a SSMHF box be placed at every general membership meeting for individual contributions. This idea will be sent to PASR state for other chapters to use.

PASR "Recommendations" - Response to the Coronavirus/COVID-19 Situation

In consideration for our membership and for the promotion of the general health of our state and country, PASR is issuing the following statement regarding continuing operations of PASR in relation to the Coronavirus or COVID-19.

- 1. It is strongly recommended that, for the months of May, June and July (2020) that all scheduled PASR meetings either be cancelled or postponed or be limited to teleconferences.
- 2. It is strongly recommended that, for the months of May, June and July (2020) that all scheduled PASR events (Pre-Retirement Fairs, fundraising activities, and sponsored trips etc.) either be cancelled or postponed.
- 3. All state related meetings will be limited to the teleconference format and any Board of Directors Meeting will be limited to the teleconference format or be postponed to a later date.
- 4. The travel of PASR elected leaders and staff will either be unavailable or extremely limited for the months of May, June and July (2020).
- 5. It is recommended that COMMUNICATION with your membership be increased during these troubled times. Counteract "social distancing" by exploring new technology options of contact. Newsletters, email messages and phone calls to keep in touch with your members will have a productive short-term and long-term impact on PASR while making sure we take care of our members.

6. It is important to note that PASR Chapters are governed by their own By-Laws and this statement is a recommendation and guideline.

7. If any governmental authority that covers, at least, the state of Pennsylvania issues a directive easing the policy of social "distancing," PASR will issue another statement in response to the new guidelines.
